Purpose of this form

Use this form to apply for an additional Category or Aircraft Type Ratings on an Australian Aircraft Maintenance Engineer (AME) Licence, based on a current and valid New Zealand Aircraft Maintenance Engineer Licence.

Who is this form for?

This form is for individuals holding a current and valid New Zealand Aircraft Maintenance Engineer Licence.

Information needed to complete this form

You must be licenced within the applicable Category for which you seek an Aircraft Type Rating before submitting this application OR be submitting Form 374 at the same time.

You will need to provide:

- Certified true copy of your NZ Licence.
- Evidence of exercising the privileges under the licence.

This application will be assessed in accordance with the *Trans-Tasman Mutual Recognition Act 1997 (TTMRA)*, with the subsequent issue of an additional Category or Aircraft Type Ratings onto your CASR Part 66 Licence if all requirements are met.

It is a regulatory requirement that licences/authorisations be verified with the NAA departments to ensure qualifications were not cancelled or revoked. The applicable issuing body may change certain fees for processing these requests. Enquire and pay any applicable fees prior to submitting this application.

This form is not for recognition of qualifications via Australian Civil, Australian Defence Force, or Foreign Civil Qualifications. You should use the appropriate forms.
