Purpose of this form

This form is used by individuals to apply for an Air Transport Pilot Licence (ATPL-H) helicopter category.

Who is this form for?

This form is for individuals who have successfully completed ATPL-H flight test.

Information needed to complete this form

If the licence holder does not currently have a CASR Part 61 licence document, they must submit <u>Recognition and Transfer CAR Part 5</u> <u>Qualifications (Form 61–9TX)</u>.

If CASA does not have a photo of the licence holder that is less than 10 years old, they must also submit <u>Lodgement of current photo with CASA</u> (Form 61–9PIC).

To be eligible for a ATPL-H, you must have passed all 7 subject part ATPL-H aeronautical knowledge exams for the helicopter category or 3 helicopter category part exams if the applicant holds a CASA issued Air Transport Pilot Licence - Aeroplane.

CASA must ensure an applicant is a fit and proper person before issuing a permission.

A CASA Flight Crew Licence cannot be issued until a security background check has been completed and has not been found adverse.

For other licence changes and requirements refer to <u>Flight Crew Licensing</u>.

Aviation Reference Number (ARN)

An ARN is required to complete this form. If you are the applicant and you do not have an ARN, <u>apply now</u>.
