### Purpose of this form

This form is used to make application to undertake training for a CASR Part 61 flight examiner rating by participating in the CASA Flight Examiner Rating Course (FERC) for 61.1290(2)(a) and 61.1320(2)(a).

### Who is this form for?

This form is for people who wish to apply for enrolment in the CASA FERC.

### Information needed to complete this form

Refer to the FERC profile for more information regarding CASA flight examiner rating training and/or assessment including important course information.

All applicants must meet the requirements specified in column 3 of Table 61.1310 of CASR Part 61 for the relevant flight examiner endorsement (FEE).

In accordance with CASR 11.055(4), CASA will take into account an applicant's experience in aviation. The expected experience levels that CASA uses as a guide to assess suitability for each flight examiner endorsement are detailed in question 9 of this form.

Applicants must provide satisfactory documentary evidence of their qualifications and experience when submitting this application. If your experience does not meet the guidelines in question 9, you will need to provide additional supporting explanations and evidence with your application. All declared experience claims will be reviewed during the application process.

Applicants must provide payment details for the standardised regulatory service fee upon submission of this application.

Where an application is not approved by CASA, an administrative assessment fee of \$240 per endorsement requested shall be charged for the administration time to review this application.
