Who is this form for?

This form is for Individuals or a legal entity to apply for a grant or re-issue of Approval as an Approved Design Organisation under CASR (1998) Subpart 21.J

Information needed to complete this form

It is the applicant's responsibility to apply for CASA approval only if they have an operational requirement for the approval and can demonstrate compliance with all the relevant regulatory requirements.

After receiving a completed Application Form, CASA will calculate and send you a cost estimate for the processing of your application and a list of any additional supporting documents required. Should you wish to formally proceed with your application, you will need to pay the cost estimate and send all supporting documentation with your payment.

Once a Subpart 21.J approval certificate has been issued, any changes to the organisation's name listed on the certificate will require a new application to be made and submitted to CASA for approval.

After reviewing your application, CASA may require you to submit additional documents to support your application.
