Who is this form for?

This form is for applying, renewing and varying a delegation to exercise CASA's power to certify a person as an RPA operator of very small or small RPA under Regulations 101.335 of the CASR.

It is the applicant's responsibility to apply for CASA delegation only if they have an operational requirement for it and can demonstrate compliance with all the relevant regulatory requirements.
