- Initial Australian Aircraft Maintenance Engineer licence based on Foreign Civil Qualifications (FCQ).
- Additional category or subcategory based on Foreign Civil Qualifications (FCQ), or to an existing licence, OR
- To apply for a modular licence based on Foreign Civil Qualifications (FCQ).

# Who is this form for?

This form is for individuals holding Foreign Civil Qualifications where the applicant's foreign licence has been assessed by a CASA approved Part 147 Maintenance Training Organisation (MTO).

Your foreign civil qualifications must have been assessed by a Maintenance Training Organisation (MTO) before you submit this form. You must obtain a copy of Form 465, completed by the MTO or the Document of Record (DOR) received from CASA, and submit it with this application.

If you are also applying for Aircraft Type Ratings, based on Foreign Civil Qualifications (FCQ), you must submit Form 545 with this application.

This form is not for if you are applying for:

- An initial issue of your CASR Part 66 Licence based on Australian Civil or Defence Force qualifications. Use Form 540 (Civil) or Form 542 (ADF), or
- If you have undertaken self-study and completed the CASA Part 66 Practical Experience Logbook.

## Information needed to complete this form

You will need to provide:

- Certified true copies of your Foreign Licence.
- Evidence of exercising the privileges of your licence or company authorisation(s).

This form can be completed electronically and saved locally to your computer. Once the ARN has been entered into the first page, it will automatically update in the applicant ARN fields on subsequent pages. CASA recommends that applicants complete as much of the form electronically as possible.

Please ensure your application and the checklist are completed correctly and that all required supporting documentation is provided. Incomplete applications will not be accepted and may be returned to you for amendment.
