## Purpose of this form

Use this form to apply for a Standard Certificate of Airworthiness.

### Who is this form for?

This form should be completed by a person applying for a certificate for an aircraft in the following categories:

- Normal
- Utility
- Acrobatic
- Commuter
- Transport
- Manned Free Balloon
- Special Class.

# Information needed to complete this form

You will need to know the registration details of your aircraft.

When you have completed the form, email it and all supporting documents it to your CASA regional office or send them to the CASA Authorised Person engaged to act on your behalf.

Payment is required for this application type in due course.

You will be notified of the payment amount once your application has been assessed and the complexity and processing time has been determined.

If you choose to submit to a CASA authorised person, they will notify you of their charge.

## **Aviation Reference Number (ARN)**

An ARN is required to complete this form.

If you are the applicant and you do not have an ARN, apply now.

If you are applying on behalf of an organisation, you will need to have authority to act on the entity's (applicant's) behalf and be able to provide the organisation's ARN.

#### **Contact details**

It is important the contact details on the ARN profile are current. CASA uses these contact details when processing this application.

If your address, contact or other details have changed, you must update them online using <u>changing your details</u> prior to lodging this form.
