CASA must ensure an applicant is a fit and proper person before issuing a permission. A CASA Flight Crew Licence cannot be issued until a security background check has been completed and has not been found adverse.

For other licence changes and requirements refer to <u>Flight Crew</u> <u>Licensing</u>.
