Purpose of this form

Use this form to apply to have Exclusions or Limitations/Conditions removed from your Australian Aircraft Maintenance Engineer Category Licence or Aircraft Type Ratings.

Who is this form for?

This form is for individuals applying to have Exclusions and/or Limitations to be removed from Aircraft Maintenance Engineer Category Licence or Aircraft Type Ratings, based on one of the following:

- Training with a CASA approved Category Maintenance Training Organisation (MTO) for Category exclusion removal.
- Training with a CASA approved Maintenance Training Organisation (MTO) or Aircraft Maintenance Organisation (AMO) for Aircraft type exclusion removal.
- The use of and completion of the relevant sections of the Part 66 Basic Practical Experience Exclusion Removal Logbook via the self-study training pathway (for category/subcategory exclusion removal only)
- Foreign Aircraft Engineer Licence exclusion removal from Aircraft Type Ratings accompanied with applicable company authorisations.
- Australian Defence Force type rating exclusion removal accompanied by applicable authorisations.
- Removal of a Limitation/Condition from Aircraft Maintenance Engineer Licence (AEL) documented in the Remarks Section XIII.

Information needed to complete this form

You must be licenced within the applicable Category for which you seek Exclusion removal and/or hold the Aircraft Type Rating before submitting this application.

You will need to provide:

- For CASA approved training, a copy of Form 465, completed by the MTO or AMO, or the Document of Record (DOR) received from CASA, and submit it with this application.
- For exclusion removal from a category/ subcategory Part 66 licence, using the self-study pathway, you must provide evidence

of the completion of the necessary examinations and completion of the relevant sections of the Part 66 Basic Practical Experience Exclusion Removal Logbook.

- For Foreign, provide a copy of foreign qualifications, you must submit certified true copies for your foreign licence and company authorisations.
- For Australian Defence you must be licenced in the applicable Category for exclusion removal from a type rating held and submit appropriate evidence as certified true copies.
- For Limitation/Conditions, evidence applicable for removal of the text annotated in the Remarks Section XIII of the AEL.

This form can be completed electronically and saved locally to your computer. Once the ARN has been entered into the first page, it will automatically update in the applicant ARN fields on subsequent pages. CASA recommends that applicants complete as much of the form electronically as possible. Please ensure your application and the checklist are completed correctly and that all required supporting documentation is provided. Incomplete applications will not be accepted and may be returned to you for amendment.
