## Purpose of this form

Use this form to apply to CASA for the initial issue, renewal, or variation (significant change) of a remotely piloted aircraft operator's certificate (ReOC) under the *Civil Aviation Safety Regulations 1998* (CASR).

## Who is this form for?

This form is for individuals and organisations to apply for:

- Initial issue of a ReOC to fly remotely piloted aircraft (RPA) commercially,
- renewal or,
- the following significant changes:
  - variation to an existing ReOC or,
  - change to nominated personnel (Chief Remote Pilot, Maintenance Controller, Chief Executive Officer or Chief RePL Instructor).

If you are **only** applying for significant or non-significant changes to your documented practices and procedures, use the [RPA Operator's Certificate \(ReOC\) – Significant Change approval and/or Notification of Non-Significant Changes application form](#).

After receiving a completed application form, CASA may contact you if any additional supporting documentation is required. If the changes requested are contrary to your declaration of changes, CASA will provide feedback and you may be required to submit an amended application form.

CASA may refuse to consider an application or to consider it further while there are requirements that the applicant has not complied with.
