## **Purpose of this form**

Use this form to request CASA to **assign marks** to an aircraft dealer, to use on any aircraft manufactured, distributed or dealt with by the dealer.

### Who is this form for?

This form is for an aircraft dealer, or an agent acting on behalf of an aircraft dealer, to apply for dealer's mark(s). You must be an aircraft dealer as defined in *CASR 47.170* and be an eligible person as defined in *CASR 47.010*.

## Information needed to complete this form

Dealer's marks are assigned to individuals or organisations engaged in the manufacture, sales or distribution of aircraft in Australia. An aircraft dealer may request more than one mark to be assigned and can also nominate specific marks (depending on availability) if wanted.

Before nominating specific marks in this application, check the <u>list of</u> available marks.

Aircraft flying under a dealers mark must comply with legal and operational requirements detailed in Section 13 of the <u>Advisory Circular AC47-1</u>.

### **Aviation Reference Number (ARN)**

An ARN is required to complete this form. If you do not have an ARN, apply now.

If you are applying on behalf of an organisation, you will need to have authority to act on the entity's (applicant's) behalf and be able to provide the organisation's ARN.
