Lodgement of current photo with CASA

Purpose of this form

Use this form to submit a recent photograph to CASA.

Who is this form for?

Applicants applying for a flight crew licence, rating or endorsement but who have not lodged a photo with CASA within the last 10 years.

This form is also for applicants applying for a Commercial Pilot (Balloon) Licence (CP(B)L) who have not lodged a photo with CASA within the last 10 years.

Refer to CASR 61.155, 11.030(1)(aa)

Information needed to complete this form

A certified photo submitted to CASA must show your full face, head and shoulders. The photo must be taken no later than 6 months before the date of submission

Check that all required questions are answered and that the form is signed and dated.

Who can certify your photo:

 Any person who is entitled to witness an Australian Commonwealth Statutory Declaration such as a Notary public, Nurse or Justice of the Peace (see <u>complete list</u> on CASA's website)

Key information about completing Australian Statutory Declarations:

- An approved witness must have a professional connection to Australia
- Having the required connection to Australia means the person is either:
 - licensed or registered to practise in Australia.
 - holds an Australian membership to a relevant professional organisation.
 - appointed in Australia.
 - the only exception are notary publics who may be registered as notary publics by an overseas entity and do not need to be registered in Australia to be an approved witness.


The diagram below shows the area the face should take up and how the photograph should be certified.

Note: CASA highly recommends you print this form out as the person certifying your identity may not be able to compete a **digital** signature for Q4. Please ensure you also bring your physical passport quality photo with you.

If posting this form to CASA, please secure a certified passport quality photo in the space below. Use low grade adhesive tape. Do **not** use staples or glue.
