## Purpose of this form

Use this form to apply for an authorisation to fly an Australian-registered aircraft either in Australia or overseas. A CoV is a short-term authorisation, valid for a period of up to 12 months (unless renewed). It is tailored to the specific operation(s) to be undertaken.

You must provide detailed information about the reasons for requiring the CoV in questions 16-17 of this form, including an end date for the operation. This will become the validity period that will be placed on the CoV.

## Who is this form for?

This form is for holders of a foreign flight crew licence granted by the National Aviation Authority of an International Civil Aviation Organization (ICAO) Contracting State.

## Information needed to complete this form

Certified/notarised copies of documents must be submitted with this application. Certification of documents can only be made by a Notary Public or a CASA DAME in your home country. Alternatively, an Australian official at any [Australian Embassy or High Commission](#) can certify your documents as certified copies of the original documents. If you are in Australia, your documents can be certified by any of the persons identified by the Australian Attorney-General Department as [authorised witnesses](#).

You must hold a current medical certificate of the relevant Class, issued by the same regulatory authority that issued your licence.

Refer to 61.300 of the Civil Aviation Safety Regulations 1998 (CASR)

If your operation requires use of an Instrument rating, you will need to provide evidence of your last proficiency check, details of the privileges you hold for instrument approaches and category ratings (e.g.: multi-engine aeroplane, single-engine helicopter).

You are required to hold at least a current ICAO level 4 Aviation English Language Proficiency ([AELP](#)) assessment.

CASA cannot finalise your application unless notified that you have completed an [aviation security status check](#) and it is not adverse or qualified.

You must provide the Civil Aviation Authority, in the country of licence issue, with the authority they require to release your information to CASA. We will contact the relevant authority to verify your licence.

If CASA does not have a photo of the licence holder that is less than 10 years old, they must also submit [Lodgement of current photo with CASA \(Form 61-9PIC\)](#).

## Contact details
