Purpose of this form

Use this form to apply for a CoV for a balloon licence on the basis of overseas civil qualifications.

Who is this form for?

This form is for overseas balloon licence holders who require a short term authorisation.

Information needed to complete this form

Authorisations resulting from this application are valid for a period of up to 3 months. It is tailored to the specific operation(s) undertaken. You must provide detailed information about why the CoV is required.

An application for a CoV may take up to 28 days to process. Please submit the application well in advance of when you require the CoV but no longer than 3 months ahead of when you require the CoV.

You must hold or have applied for an Aviation Security Identification Card (ASIC) or Aviation Identification (AVID).

You must possess a knowledge of the English language that is sufficient to enable you to safely exercise the authority given by this CoV. CASA will be satisfied you possess satisfactory knowledge if you hold a minimum of a Level 4 ICAO English Language Proficiency (ELP) standard.

Certified true copies of logbook pages of the last 3 months or last 3 full page openings (whichever is the lesser) of your current logbook must be attached to this application.

Evidence of balloon class/size endorsements should also be included, if applicable. If further evidence is required by CASA, you will be notified.

You are not required to satisfy the Australian aeronautical experience requirements if you hold the equivalent or higher class of foreign licence.

If CASA does not have a photo of the licence holder that is less than 10 years old, they must submit Lodgement of current photo with CASA Form 61-9PIC Lodgement of current photo with CASA.

Aviation Reference Number (ARN)

An ARN is required to complete this form. If you do not have an ARN, [apply now](#).

If you are applying on behalf of an organisation, you will need to have authority to act on the entity's (applicant's) behalf and be able to provide the organisation's ARN.
