Purpose of this form

Use this form to apply for an exemption from, or variation of, requirements of a prescribed regulation or in a related document for an aircraft or aeronautical product maintained under the Civil Aviation Regulations 1988 (CAR).

Refer to CAR 42ZQ for prescribed regulations and related documentation.

Application form CASA-04-6209 should be used for Time Between Overhaul (TBO) extension of an Aircraft Piston Engine or a Piston Engine Propeller.

Application for an aircraft where the Continuing Airworthiness is managed under CASR Part 42 should be made on form 42-02.

Who is this form for?

This form is for the registered operator of the aircraft or nominated agent. If the person making the application is not the registered operator, the application must be accompanied by a letter demonstrating the applicant has the authority of the registered operator.

Information needed to complete this form

You will need to support this application with technical information and associated supporting documentation to demonstrate why an exemption from, or variation of, requirement should be considered. A No Technical Objection (NTO) letter from the aircraft manufacturer/ State of design National Airworthiness Authority (NAA) may assist with any application. Ref AWB 00-024 for CASA NTO policy

Aviation Reference Number (ARN)
