**IMPORTANT INFORMATION FOR APPLICANTS**

- 1: This form is to be used by applicants who hold a pilot certificate granted by a recreational aviation administration organisation and wish to transition to a CASA issued Recreational Pilot Licence (RPL).
- 2: If CASA does not already have a current photo of you (less than 10 years old), you must submit a current photo (not less than 6 months old) with this application using Form 61-9PIC – Lodgement of Current Photo with CASA.
- 3: For security requirements associated with the issue of this licence please refer to the [ASICs and AVID](#) page.
- Note:** A CASA Flight Crew Licence cannot be issued until you have been issued with an ASIC or AVID.
- 4: CASA must ensure an applicant is a fit and proper person before issuing a permission. Therefore the information requested in *Section A3* is still required, even if you hold a valid ASIC or AVID.
- 5: If you have a flight radio endorsement on your pilot certificate granted by a recreational aviation administration organisation, CASA cannot issue the endorsement on your RPL *unless* you hold a valid ICAO Level 4 Aviation English Proficiency or are submitting an ELP notification with this application (CASR 61.500(4)(c)).
- 6: If your pilot certificate authorises you to conduct cross-country flight and you meet the minimum hours, you will be issued with a recreational navigation endorsement.
- 7: Your pilot certificate issued by a recreational aviation administration organisation does not satisfy the requirements for issue of controlled airspace or controlled aerodrome endorsements onto the RPL. If you wish to add these endorsements to your RPL, you must meet the CASA requirements, including holding a valid ICAO Aviation English Language Proficiency, passing the required aeronautical examinations and completing the flight training. Meeting the requirements of the General English Language Proficiency (Section 5.1.2 of the Manual of Standards) is not sufficient. A completed Form 61-1RE must be submitted with this application.
- 8: Payment for this application can be made [online](#). Go to the CASA webpage and click the Payment button. You must attach a copy of the receipt with this application.
- 9: This form can be **completed electronically and saved locally** to your computer. Once the ARN has been entered into the first page, it will automatically update in the applicant ARN fields on subsequent pages. CASA recommends that applicants complete as much of the form electronically as possible.
- 10: If you do not have an ARN, you must submit **Form 1162** (Aviation Reference Number (ARN) Application) including appropriate identification with **this** application. This will satisfy the mandatory requirement for the ARN.
- 11: Please ensure your application and the checklist are completed correctly and that all required supporting documentation is provided. **Incomplete applications will not be accepted** and will be returned to you for amendment. **Fields marked with an \* are mandatory.**
