Delegations — extension of operation of delegation instruments

1 Duration

This instrument:

- (a) commences on the day of signature; and
- (b) is repealed at the end of 30 June 2018.

2 Application

This instrument applies to each of the instruments of delegation referred to in section 4, other than a superceded instrument referred to in section 5.

3 Extension of instruments

Subject to section 2, each of the instruments of delegation referred to in section 4 is amended by omitting the reference in the instrument to the date on which the instrument expires, stops or ceases to have effect (however referred to), and inserting 30 June 2018.

4 Identification of instruments

For section 3, the instruments of delegation are the following:

- (a) subject to section 5, each of the instruments of delegation mentioned in Schedule 1 of each of the following instruments (*omnibus instruments*):

- (b) subject to section 5, each of the additional instruments mentioned in Schedule 1 of this instrument.

5 Superceded instruments

Despite sections 3 and 4, section 3 does not apply to an instrument of delegation (a *superceded instrument*) whose holder has been granted a flight examiner rating in accordance with subregulation 202.272 (2) of CASR 1998 as a replacement for the holder's instrument of delegation.

Note When, in accordance with subregulation 202.272 (2) of CASR 1998, a flight examiner rating is granted to a person, with privileges equivalent to the privileges conferred by the person's instrument of delegation, subregulation 202.261 of CASR 1998 has the effect that the holder's instrument of delegation is taken to have ceased.
