### Purpose of this form

This form is used by individuals to apply for a Part 61 Private Pilot Licence or Commercial Pilot Licence and Operational Ratings on the basis of Australian Defence Force qualifications.

The information on this form includes key points. For more detailed information go to the <u>CASA website</u>.

### Who is this form for?

This form is for Australian Defence Force pilots who have graduated with a recognised ADF course (as specified in the Flight Crew Licence Manual) and the qualification deemed equivalent for the issue of an Australian Private or Commercial pilot's licence without undertaking any further training. They must however, meet the minimum aeronautical experience requirements set out in the CASRs for the licence sought.

### Information needed to complete this form

For currently serving and former ADF personnel, confirmation of your aeronautical experience must be annotated in relevant sections for the Flight Crew Licence level.

- To qualify for a Part 61 Private or Commercial Pilot licence, you must have completed specific courses. These courses are identified in the question 17. To qualify for a flight instructor rating you must have completed the appropriate course, identified under Flight Instructor Rating section.
- You must include a certified true copy of specific pages of your logbook that provide evidence of your qualifications. The pages required include the Certificate of Qualifications as a Pilot (aircraft type endorsement, initial and postgraduate flying qualifications, competencies and renewals). You must also include the last 3 full page openings of your logbook (do not submit PMKeys reports or ADO Service records).

- You must meet security requirements before being issued a flight crew licence. Refer to the <u>ASICs and AVIDs webpage</u> for details. A CASA Flight Crew Licence cannot be issued until you have been issued until an aviation security background check has been completed and not been found adverse.
- CASA must ensure an applicant is a fit and proper person before issuing a permission. Therefore, the information requested in this form is still required, even if you hold a valid ASIC or AVID.
- If CASA does not have a photo of you that is less than 10 years old, you must also submit <u>Lodgement of current photo with CASA</u> (Form 61-9PIC).
- For any licence level, category, operational ratings, flight activity endorsements and design features that you are applying, you must meet the relative aeronautical experience, be competent and rated on them and need to be confirmed by the evidence provided.

### **Aviation Reference Number (ARN)**
