## **Purpose of this form**

Use this form to apply for a Glider Pilot Licence (GPL).

#### Who is this form for?

This form is for individuals who have a glider pilot certificate issued by the Gliding Federation of Australia (GFA).

## Information needed to complete this form

To complete this form, you will need to provide a letter from the GFA, on GFA letter head stating that your GFA certificate was granted based on you meeting the competency standards that are at least equivalent to the competency standards for the GPL mentioned in the guidelines.

You must provide certified copies of documents as a part of this application. For more information on certified copies and who can witness them, see the CASA website.

A CASA Flight Crew Licence cannot be issued until you have been issued with an Aviation Security Identification Card (ASIC) or Aviation Identification (AVID). For security requirements associated with the issue of this licence please refer to the guidelines.

To be issued with a flight radio endorsement based on your pilot certificate, you will need to hold a valid International Civil Aviation Organisation (ICAO) level 4, or higher, Aviation English Proficiency (AELP) assessment or you are submitting an AELP notification with this application.

If CASA does not have a photo of you that is less than 10 years old, you must also submit <u>Lodgement of current photo with CASA (Form 61-9PIC)</u>.
