Purpose

Subparagraph 145.A.65 (b) 1 of the Part 145 Manual of Standards (MOS) requires a Part 145 Approved Maintenance Organisation (AMO) to have procedures in its exposition that ensure good maintenance practices and compliance with the MOS, which include taking into account human factors principles and human performance limitations. In preparing such procedures, an AMO or applicant for an approval certificate may have regard to ICAO Doc 9824 AN/450.
