### **Purpose of this form**

Use this form to apply for the **reservation** of an Australian VH- registration mark.

#### Who is this form for?

This form is for the owner (or authorised representative) of an aircraft, to request CASA to reserve a **specific registration mark** for an aircraft.

You can reserve a registration mark for an aircraft which will be registered in the Australian Civil Aircraft Register, or to change the registration mark on a currently registered aircraft. Mark reservations will **lapse 12 months** after the day the mark was reserved by CASA.

You **do not need** to reserve a registration mark prior to registering an aircraft – if you have not reserved a mark, CASA will assign one. To apply for **registration of an aircraft** refer to Aircraft register forms and fees.

## Information needed to complete this form

Only one mark can be reserved per form.

The reservation will be valid for **12 months** from the date of reservation or until the aircraft is registered in the Australian Civil Aircraft Register, whichever occurs first.

If the initial 12-month reservation period expires without the mark being placed on a registered aircraft, the **mark will be returned** to the 'available' pool of marks.

**No reminder** about a reservation expiry date, or notification that a reservation has expired, will be sent by CASA.

You may apply to reserve the same mark again if an application is submitted within 2 weeks of the reservation expiring or it is found in the available marks list.

Mark reservation applications are processed in **order of receipt**. If the same mark is requested by two different parties on the same day, the mark will be reserved for the first reservation received, provided the application is completed correctly.

## **Aviation Reference Number (ARN)**

An ARN is required to complete this form.

If you are the applicant and you do not have an ARN, <u>apply now</u>. If you are applying on behalf of an organisation, you will need to have authority to act on the entity's (applicant's) behalf and be able to provide the organisation's ARN.

#### Contact details

It is important the contact details on the ARN profile are current. CASA uses these contact details when processing this application.

If your address, contact or other details have changed, you must update them online using <u>changing your details</u> prior to lodging this form.

Failure to provide up to date contact details to CASA could result in additional fees being charged under the *Civil Aviation (Fees)*Regulations 1995 and may constitute a criminal offence.

### **Privacy**

Any personal information you provide to CASA is protected by the Privacy Act 1988. CASA can only collect, use and disclose that information in accordance with that Act.
