Who is this form for?

- Change of Nominated Personnel <u>Nominated Personnel Approval</u> (Form 004) required to be submitted
- Change of Organisational Structure
- Change of Postal address and/or contact details
- Other changes to the exposition or related manuals or procedures that do not maintain or improve aviation safety

After receiving a completed application form, CASA will calculate and send you a cost estimate for the processing of your application and a list of any additional supporting documents required. You will need to pay the estimate and send additional supporting documentation with your payment before any assessment of your application can occur.

Aviation Reference Number (ARN)

An ARN is an identifier that is similar to an account or customer number. You will need an ARN to complete this form.

If you do not have an ARN, apply for an ARN.

If you are applying on behalf of an organisation, you need to provide the organisation's ARN and have authority to act on behalf of the entity.
