# Guidelines

This form is applicable to COA holders applying for subsequent issue of a COA without changes.

#### Part A — Details of COA holder

We have completed this section based on the information we have on record.

If your legal name has changed, you may need to vary your Certificate of Approval (COA). Please contact the Permission Application Centre on 136 773 for more information.

**Trading Name** — A registered business name is the trading name under which a person carries on a business or trade. Trading names are issued by the State or Territory in which the business or trade is registered.

The trading name must meet the following criteria for it to appear on your COA:

- its registration must be current at the time of issue of the COA; and
- it must be registered in the name of the COA holder as the proprietor.

The Permission Application Centre will verify the currency of the registration and the ownership of the trading name. If you do not have a trading name, but would like to nominate one for the next issue, please write your nominated trading name in the field provided.

**Main Location** — If you have changed your main location, you may need to vary your Certificate of Approval (COA). Please contact the Permission Application Centre on 136 773 for more information.

### Part B — Contact details

You only need to complete this section if the contact details in Part A have changed or are incorrect.

#### Part C — Use of an agent

You may by law appoint an agent to complete and sign the application on your behalf and to negotiate with CASA in relation to all matters necessary to complete this application.

If you wish to authorise an agent to act on your behalf, CASA requires that the agent be appointed under a Power of Attorney. The Power of Attorney must be executed and signed by all applicants or in the case of a company, by a Director of that company.

CASA will not recognise any other method for the appointment of an agent for the purpose of signing application forms.

CASA may deal with the nominated agent in ALL matters relating to this COA application. This means that you will be taken to have received any communication about your application sent to the agent as if they were sent to you personally. CASA will consider the authority of the agent to have ceased once the COA has been issued.

## **Privacy policy**

CASA is authorised under *Civil Aviation Regulation 30* to approve this Form 692 and thereby collect information outlined in this form for the purpose of a COA application. All such information received will be treated as being confidential. CASA is bound by the Privacy Act to safeguard personal information within the terms of that Act.
