## **Purpose of this form**

Use this form to apply for the cancellation of the registration of a currently registered aircraft, in accordance with regulation 11.130 or 47.132 of the Civil Aviation Safety Regulations 1998 (CASR).

If there has been a change in the aircraft ownership, or if other aircraft details have changed, please refer to the relevant forms and instructions Aircraft Register Forms and Fees.

#### Who is this form for?

This form is for the aircraft registration holder to request cancellation of the registration of a currently registered aircraft.

## Information needed to complete this form

This form may **not** be used if an Irrevocable Deregistration and Export Request Authorisation (IDERA) is recorded for the aircraft. Deregistration can then only be requested by the authorised person under the IDERA by submitting a

Irrevocable De-registration and Export Request Authorisation (IDERA) or Certified Designee Confirmation Letter (CDCL) - De-registration Request (Form 1542).

The registration will be cancelled as soon as possible after receipt of this form, so **do not lodge** until the registration holder is **ready for the cancellation to take place**. It is the responsibility of the registration holder to ensure that the aircraft is not, and will not be, operating under Australian registration once this application is submitted.

## **Aviation Reference Number (ARN)**

An ARN is required to complete this form. If you do not have an ARN, apply now.

If you are applying on behalf of an organisation, you will need to have authority to act on the entity's (applicant's) behalf and be able to provide the organisation's ARN.

#### Contact details

If your address, contact or other details have changed, you must update them online using changing your details prior to lodging this form.
