### **Purpose of this form**

Use this form to apply for a **change of registration mark** on an aircraft that is already VH registered in accordance with regulation 47.165 of the *Civil Aviation Safety Regulations 1998 (CASR)*.

### Who is this form for?

This form is for the aircraft registration holder, or an authorised registered operator with written consent from the registration holder, to request a change to an aircraft registration mark.

### Information needed to complete this form

You need to <u>reserve a registration mark</u> before you can apply to use it on an aircraft.

An approval letter will be issued by CASA when the change of mark is approved. The aircraft must not be flown under the new registration mark until the new certificate of registration and certificate of airworthiness, bearing the new registration mark, are issued on or after the nominated date of effect of the mark change.

If there has been a change in the aircraft **ownership**, or to other aircraft details please refer to the relevant forms and instructions <u>Aircraft register forms and fees</u>.

The applicant should ensure that:

- contact is made with Regulatory Services prior to the nominated date of change, to ensure that additional requirements relating to the mark change are met
- the date of effect for the mark change takes in to account the time required to meet all the requirements outlined in <u>Certificate of Airworthiness due to Change of Registration Mark</u> <u>Application & Approval</u>. This form is required for the issue of the new Certificate of Airworthiness.

The following rules must be observed when nominating a date of effect for the mark change. The nominated date of effect:

• must be a weekday

- must be a day on which the Australian Civil Aircraft Register is open for business
- must be at least 14 days after CASA receives your application
- must take in to consideration the time it will take to meet the airworthiness requirements in relation to the reissue of the certificate of airworthiness (see <u>Certificate of Airworthiness due to</u> <u>Change of Registration Mark Application & Approval</u> on CASA's website and liaise with Regulatory Services).
- must take in to consideration the fact that aircraft cannot operate on the date of effect until both the new certificate of registration and certificate of airworthiness are issued.

## **Aviation Reference Number (ARN)**

An ARN is required to complete this form. If you do not have an ARN, <u>apply now</u>.

If you are applying on behalf of an organisation, you will need to have authority to act on the entity's (applicant's) behalf and be able to provide the organisation's ARN.

### **Contact details**

It is important the contact details on the ARN profile are current. CASA uses these contact details when processing this application.

If your address, contact or other details have changed, you must update them online using <u>changing your details</u> prior to lodging this form. Failure to provide up to date contact details to CASA could result in additional fees being charged under the *Civil Aviation (Fees) Regulations 1995* and may constitute a criminal offence.
