- (c) paragraph 6(3)(b) of *CASA OAR 228/23 – Declarations and Directions in relation to Prohibited, Restricted and Danger Areas, Etc. – Permanent Instrument 2023* (the **Declaration**).

### CASA OAR 227/23 — DAH Authorisation Instrument 2023

---

#### 1 Name

This instrument is *CASA OAR 227/23 — DAH Authorisation Instrument 2023*.

#### 2 Commencement

This instrument commences on 30 November 2023.

#### 3 Definitions

- (1) In this instrument:

**Declaration** means *CASA OAR 228/23 – Declarations and Directions in relation to Prohibited, Restricted and Danger Areas, Etc. – Permanent Instrument 2023*.

**Determination** means *CASA OAR 226/23 — Determination of Airspace and Controlled Aerodromes, Etc. (Designated Airspace Handbook) Instrument 2023*.

- (2) In this instrument, words and phrases have the same meaning as in the Declaration or the Determination, as the case requires.

#### 4 Application

This instrument applies only for the purposes of:

- (a) subsection 6(2) of the Determination; and
- (b) paragraph 8(2)(b) of the Determination; and
- (c) paragraph 6(3)(b) of the Declaration.

## **5 Authorisation of AIP and NOTAM**

- (1) For subsection 6(2) of the Determination, this authorisation applies for a volume of airspace that is classified under Schedule 3, 4, 5, 6, 7, 8 or 9 of the Determination as being of a class (*initial classification*) for hours of activity as specified by the AIP or a NOTAM.
- (2) For the volume of airspace, I authorise the AIP or a NOTAM that specifies the hours of activity for the initial classification.

*Note* A later specification may modify an earlier specification and is also authorised by subsection (2).

- (3) If the air traffic control service for a volume of airspace is suspended or ceases to function, I authorise a NOTAM that specifies the suspension or cessation.

*Note* Classified airspace becomes Class G airspace when, in accordance with the AIP or a NOTAM authorised by the delegate, air traffic control services are not available.

- (4) The authorisation of the AIP or a NOTAM mentioned in subsection (2) ceases to have effect if the authorisation is repealed in writing by me.

*Note* If the authorisation of the AIP or a NOTAM is repealed, authorised providers of air traffic control services will be notified and the repeal published by NOTAM.

## **6 Authorisation of voice deactivation of a Class C Control Zone**

- (1) For paragraph 8(2)(b) of the Determination, this authorisation applies for a voice deactivation of a Class C Control Zone under section 8 of the Determination.
- (2) For the Class C Control Zone, I authorise the early deactivation of the Control Zone by the Controlling Authority provided that the requirements of section 8 of the Determination have been complied with.
- (3) The authorisation ceases to have effect if the authorisation is repealed in writing by me.

*Note* If the authorisation is repealed, relevant Controlling Authorities will be notified.

## **7 Authorisation of voice deactivation of a restricted area or a danger area**

- (1) For paragraph 6(3)(b) of the Declaration, this authorisation applies for a voice deactivation of a restricted area or a danger area under section 6 of the Declaration.
- (2) For the relevant restricted area or a danger area, I authorise the early deactivation of the area by the Controlling Authority, Administering Authority or Contact, as applicable, provided that the requirements of section 6 of the Declaration have been complied with.
- (3) The authorisation ceases to have effect if the authorisation is repealed in writing by me.

*Note* If the authorisation is repealed, the relevant Controlling Authority, Administering Authority or Contact, as applicable, will be notified.
