### Purpose of this form

Use this form to notify CASA of non-significant change/s under Parts 119, 131 and 138 of CASR.

### Who is this form for?

This form is for individuals or organisations who wish to notify CASA of non-significant changes made to their operations manual/exposition for Parts 119, 131 and 138.

If notifying of non-significant changes in relation to your legal entity name and/or trading name changes, you are required to complete and submit the application form/s for [Part 119](#), [Part 131](#) and/or [Part 138](#) as applicable to your operations.

If notifying of non-significant changes in relation to your Part 145 or Part 42 certificates, you are required to complete and submit [Form 395](#).

### Information needed to complete this form

The operator should review CASR Parts 119, 131 and/or 138 (as applicable) before completing this form.

After receiving a completed form, CASA may contact you if any additional supporting documentation is required. If the changes requested are considered a **significant change** to your operations, you are required to complete and submit the correct application form.

Non-significant changes are not chargeable items under the Civil Aviation (Fees) Regulations 1995 and you will not receive an estimate for these changes.

### Aviation Reference Number (ARN)

An ARN is required to complete this form. If you do not have an ARN, [apply now](#).

If you are applying on behalf of an organisation, you will need to have authority to act on the entity's (applicant's) behalf and be able to provide the organisation's ARN.
