Purpose of this form

Use this form to apply for the initial issue of, renewal of, or to request changes to, general approvals issued under Part 131 of CASR (Part 131).

Who is this form for?

This form is for individuals or organisations, other than AOC holders, who wish to apply for the initial issue of, renewal of, or request changes to, approvals under Part 131.

This form is not for individuals or organisations applying for an AOC (or approvals associated with balloon transport operators). Please use the Air Operator's Certificate (balloon operations)/associated approvals application form.

This form is not for individuals or organisations applying for an approval under Part 91 of CASR (Part 91). Please use the Part 91 general approval application form for Part 91 approvals (except for air display approvals) or the approval to conduct air display application form.

Information needed to complete this form

You should review Parts 91 and 131, associated manuals of standards, and associated AMC/GM documents before completing this form.

Guidance is available in the form of AMC/GM documents and advisory circulars. Refer to the <u>CASA website.</u>

After receiving a completed application form, CASA will calculate and send you a cost estimate for the processing of your application and a list of any additional supporting documents required. You will need to pay the estimate and send additional supporting documentation with your payment before any assessment of your application occurs.

Aviation Reference Number (ARN)

An ARN is required to complete this form. If you do not have an ARN, <u>apply now</u>.

If you are applying on behalf of an organisation, you will need to have authority to act on the entity's (applicant's) behalf and be able to provide the organisation's ARN.
