Purpose of this form

Use this form to request CASA to record a Certified Designee Confirmation Letter (CDCL) where an Irrevocable De-registration and Export Request Authorisation (IDERA) has been recorded on the Australian Civil Aircraft Register.

Who is this form for?

This form is for the **authorised party** under the IDERA to request CASA to record a CDCL in favour of the **certified designee**.

By lodging this request, the authorised party accepts that, provided the CDCL meets all requirements and no other certified designee is recorded, CASA will record the CDCL on the Australian Civil Aircraft Register.

Information needed to complete this form

The beneficiary of a Certified Designee Confirmation Letter (CDCL) (the certified designee) must have an Aviation Reference Number (ARN) in order for the CDCL to meet CASA's requirements and be recorded on the Australian Civil Aircraft Register.

This form can only be submitted if an IDERA has been recorded for the aircraft on the Australian Civil Aircraft Register.

This form must be signed and submitted in **original hard copy** to the Civil Aircraft Register, Civil Aviation Safety Authority, Australia by mail or courier. The application **cannot be accepted via email or fax** as per the legislative requirements.

Aviation Reference Number (ARN)

An ARN is required to complete this form. If you do not have an ARN, <u>apply now</u>.

If you are applying on behalf of an organisation, you will need to have authority to act on the entity's (applicant's) behalf and be able to provide the organisation's ARN.

It is important the contact details on the ARN profile are current. CASA uses these contact details when processing this application.

If your address, contact or other details have changed, you must update them online using <u>changing your details</u> prior to lodging this form.

Failure to provide up to date contact details to CASA could result in additional fees being charged under the *Civil Aviation (Fees) Regulations 1995* and may constitute a criminal offence.
