Purpose of this form

Use this form if you intend to apply for an approval or authorisation under the Civil Aviation Safety Regulations 1998, not covered by the remotely piloted aircraft authorisation application (form 101-09) or the extended visual line-of-sight (EVLOS) approval application form.

Who is this form for?

This form is for use by individuals and organisations who operate micro RPA and holders of an RPA Operator's Certificate (ReOC). For ReOC holders, this form should be submitted by the Chief Remote Pilot.

This form can be used to apply for approvals such as, but not limited to:

- 1:many operations (e.g. drone light shows) (CASR 101.029)
- Operations within 30 m of people (CASR 101.029)

Information needed to complete this form

Applicants should review the relevant Part 101 CASR and Manual of Standards provisions before completing this application.

Applicants are required to complete and submit ALL parts of the application to be acceptable to CASA.

The completion of this application form is the first step in the application process. On receipt of a completed application form, CASA will calculate and send you an estimate of the cost to process your application and any additional information you must submit.

Should you wish to proceed, you will need to pay the estimate and send any requested documents to CASA.

CASA may refuse to consider an application or to consider it further while there are requirements that the applicant has not complied with.
