Purpose of this form

Use this form to apply for a Instructor Private Pilot (Balloon) Permit, to upgrade from Grade 2 to Grade 1 or to renew an existing Grade 1 or Grade 2 permit.

Who is this form for?

This form is for individuals who are at least 18 years old who are eligible to apply for a Instructor Private Pilot (Balloon) Permit or individuals that would like to renew their Instructor Private Pilot (Balloon) Permit.

Information needed to complete this form

- You must hold a current Private Pilot (Balloon) Permit or overseas equivalent, for a period of at least 2 years.
- If using an overseas equivalent for a Grade 1 Instructor Rating, you must hold a current overseas equivalent instructor rating.
- Overseas qualifications must be verified by the foreign state of issue.
- You must have passed a flight test in accordance with the requirements contained in this form and the CASA Recreational Balloon Procedures Manual.
- You must have the aeronautical experience as required and contained in the CASA Recreational Balloon Procedures Manual for the issue of an instructor rating Grade 1 or Grade 2.
- If applying for a Grade 1 Permit based on recognition of CPL instructor rating complete sections 1 to 6 only.
 - Insert your CPL instructor rating information in Section 5 as per 2.5.2.3 of the CASA Recreational Balloon Procedures Manual.

- **Balloon size:** The flight test or flight instructor proficiency check must be carried out in a balloon of 120,00 cubic feet or less.
- **First part of flight:** Shall be at least 30 minutes duration, instructing a student (simulated student may be examiner or actual student), incorporating pre-exercise briefing and follow-up debriefing analysis of the students' performance. Flight to consist of instructor demonstrated flight skills and student flying.
- **Second part of flight:** Shall be at least 30 minutes duration demonstrating a high degree of skill, airmanship, flight management, situational awareness and an ability to recover from unusual situations.
- Exercises may be conducted with a simulated or actual student. In case of actual student, instructional flight time may be logged.
- In-flight emergencies **MUST** be simulated and not place aircraft at risk.
- Student responses to be analysed and corrective measures applied.
- **Initial issue:** Completed form to be sent to CASA with this application. Copies shall be retained by examiner.
- **Renewal:** Completed form is to be forwarded to CASA. Copies shall be retained by examiner. For renewals only, first and second parts of flight test may be a concurrent flight of not less than 30 minutes.
- A flight instructor proficiency check may be carried out up to 90 days prior to expiry of the 24 months to avoid loss of continuity. If the flight instructor proficiency check is passed up to 90 days prior to the end of the two-year validity period, it is considered to have been completed on the final day of the validity period.
- If the applicant is assessed as competent the reviewing officer must make an entry in the table in the pilot's ballooning permit that a flight instructor proficiency check has been completed.
- The validity date is two years from the last day of the month in which the flight proficiency check was conducted (or final day of the validity period if carried out up to 90 days prior to expiry as above).
- If the overall assessment is **not yet competent** the Private Pilot (Balloon) Flight Instructor Rating test form is to be forwarded to CASA. Copies shall be retained by Examiner.
- The instructor assessment is based on pilot competency. To be deemed competent overall, the pilot being assessed must achieve a competent result for all exercises.
 - a. If any core requirements (in bold) are assessed as not yet competent, the candidate will be deemed **not yet competent** overall and another flight test must be undertaken.
- **Submission:** Send this form to CASA within 14 days of the flight test or proficiency check.
