Purpose of this form

Use this form to submit an application to CASA to operate a model aircraft, where a CASA authorisation is required for the activity.

Who is this form for?

This form is for a model aircraft operator or their authorised representative.

Information needed to complete this form

Provide a map (or maps) of area of operation, these can include:

- An aerial view of the location, such as a screenshot from Google Earth or a diagram
 - Co-ordinates showing the requested area of operation
 - Outline any no-fly zones or buffered area(s)
 - Identity the location of the flight line and/or pilot's box
 - Outline the area(s) where members of the public will be segregated
- Any applicable aviation navigation charts (VTC/VNC/WAC)

The application **must be** submitted with the following:

- A risk assessment using the <u>'Airspace Risk Assessment' (Form 1589)</u>.
- Evidence of stakeholder engagement
 - Neighbourly agreements (if required)
 - Letters of Agreements with controlling authorities (if required)

Aviation Reference Number (ARN)
