If CASA does not have a photo of you that is less than 10 years old, they must also submit <u>Lodgement of current photo with CASA (Form 61-9PIC)</u>.

If the licence holder seeks a subsequent reprint of their licence, they must complete and submit the Licence Reprint application.

## **Aviation Reference Number (ARN)**

An ARN is required to complete this form. If you do not have an ARN, <u>apply now</u>.
