## **Purpose of this form**

Use this form to notify CASA of a flight activity endorsement.

#### Who is this form for?

This form is to be used by persons who currently hold a Part 61 Flight Crew Licence and seek to add a flight activity endorsement.

## Information needed to complete this form

- The applicant is aware that the minimum requirement to exercise the privilege of a flight activity endorsement is a current CASA Class 2 medical (CASR 61.1155(2)).
- If CASA does not have a photo of the applicant that is less than 10 years old, they must also submit <u>Lodgement of current photo with CASA(Form61-9PIC)</u>.
- If the licence holder seeks a subsequent reprint of their licence, they must complete and submit the Licence Reprint application.

## **Aviation Reference Number (ARN)**

An ARN is required to complete this form. If you do not have an ARN, apply now.

#### **Contact details**

It is important the contact details on the ARN profile are current. CASA uses these contact details when processing this application.

If your address, contact or other details have changed, you must update them prior to lodging this form. You can do this by <u>changing your</u> details on the CASA website.
