Purpose of this form

This form is to be used to notify CASA of the **initial issue** of an operational rating and relevant endorsements under *Civil Aviation Safety Regulations 1998* (CASR) Part 61.

Who is this form for?

This form is for pilots who **already hold** a CASA Part 61 licence, to notify of an **initial** operational rating.

Information needed to complete this form

You are required to hold the appropriate licence for the requested operational rating and endorsement(s).

Prerequisite flight test and exams must be undertaken before the rating can be issued and the applicant must also hold the appropriate medical certificate or exemption under CASR 61.235 (4)(b).

If the licence holder does not currently have a CASR Part 61 licence document, they must submit Recognition and Transfer CAR Part 5 Qualifications (Form 61-9TX).

If CASA does not have a photo of the licence holder that is less than 10 years old, they must also submit Lodgement of current photo with CASA (Form 61-9PIC).

If the licence holder seeks a subsequent reprint of their licence, they must complete and submit the Licence Reprint application.

Aviation Reference Number (ARN)

An ARN is required to complete this form. If you do not have an ARN, [apply now](#).
