Purpose of this form

This form is used to notify GFA of a transfer of ownership of a VH registered aircraft from one owner to another under Part 47 of the Civil Aviation Safety Regulations 1998 (CASR).

Who is this form for?

The **current registration holder** (the former owner) or their authorised representative must complete and give to GFA within 14 days, after the date of completion of the transfer of ownership.

A copy of the completed form must also be given to the **new owner** within 14 days, after the date of completion of the transfer of ownership, along with the original certificate of registration.

The new owner must complete <u>Transfer of Aircraft Ownership (Glider</u>) and return to GFA within 28 days after asset transfer. Failure to submit Form 1327 Part 2 within 28 days could result in suspension of aircraft registration.

Information needed to complete this form

If the registered holder is an organisation, government body or a foreign corporation this form can be authorised by an office holder of the organisation. The office held should be written in the capacity field provided in the declaration. An office holder can also authorise another person to sign on behalf of the organisation. A copy of an authority to act on the office holders behalf must be attached with the form. The authority can take the form of a power of attorney, agency agreement, or simple letter signed by the applicant confirming the authority of the third party to act on their behalf.

An individual can give another person written authorisation to sign this form on their behalf. The basis on which the individual is being represented must by written in the declaration and a copy of an authority to act on the individuals behalf must be attached with the form. The authority can take the form of a power of attorney, agency agreement, or simple letter signed by the applicant confirming the authority of the third party to act on their behalf. If the former owner was an individual who has passed away, this form needs to be completed in the name of the deceased party and signed by the executor of the estate.

For information on the documents required when submitting on behalf of the deceased party, please read the <u>guidance for deceased estates</u>.

Aviation Reference Number (ARN)

An ARN is required to complete this form. If you do not have an ARN, <u>apply now</u>.

If you are applying on behalf of an organisation, you will need to have authority to act on the entity's (applicant's) behalf and be able to provide the organisation's ARN.

It is important the contact details on the ARN profile are current. CASA uses these contact details when processing this application.

If your address, contact or other details have changed, you must update them prior to lodging this form. You can do this by <u>changing your</u> <u>details</u> on the CASA website.
