Use this form to apply for an initial Part 66 aircraft engineer licence, the addition of a category/subcategory to such a licence, or an initial Part 66 modular licence based on the self-study training pathway.

### Who is this form for?

This form is for individuals applying for an initial Part 66 aircraft engineer licence, additional privileges for such a licence, or an initial Part 66 modular licence, based on the self-study training pathway described within sections 66.A.25 & 66.A.30 of the Part 66 MOS.

This form is not for applications for an initial Part 66 aircraft engineer licence, the addition of a category/subcategory to such a licence, or an initial Part 66 aircraft engineer modular licence, based on training and assessment through a CASA approved MTO. This form is also not to be used for recognition of qualifications via Australian Defence Force, New Zealand or Foreign qualifications. You should use the appropriate form for these applications.

- Completion of the CASA module 7, 9 & 10 essays is necessary to determine English language proficiency for this application.
