Use this form to seek production authorisation to manufacture aircraft, aircraft engines, propellers, or aircraft parts, articles or appliances.

# Who is this form for?

This form is for an individual or organisation who are seeking **initial approval** to manufacture an aircraft, aircraft engine, propeller or aircraft parts, articles or appliances or seeking to **vary an existing approval**.

If you are applying for multiple production authorisations, you must complete and submit additional applications for each authorisation.

# Information needed to complete this form

You will need to attach evidence where applicable to support application.

# **Aviation Reference Number (ARN)**

An ARN is an identifier that is similar to an account or customer number. You will need an ARN to complete this form.

If you do not have an ARN, apply for an ARN.

If you are applying on behalf of an organisation, you need to provide the organisation's ARN and have authority to act on behalf of the entity.

# **Contact details**

CASA will use the currently held contact details linked to your ARN profile. If your address, contact or other details have changed, you must update them online using <u>changing your details</u> prior to lodging this form.
