## Purpose of this form

Use this form to notify CASA of any *Civil Aviation Regulation* (CAR) Part 5 Australian domestic qualifications issued by entries or stamps in a log book (or by any other Instrument) that may be recognised and transferred onto your *Civil Aviation Safety Regulation* (CASR) Part 61 licence.

## Who is this form for?

This form is for current licence holders who have CAR Part 5 Flight Crew Licence that they have yet to transfer to a Part 61 licence.

## Information needed to complete this form

If you are seeking to add additional permissions to your licence, you may need to provide evidence to support your request.

You must provide certified copies of documents as a part of this application. Each section of the form provides guidance on the evidence to be provided. For more information on certified copies and who can witness them, see the CASA website.

Some documents can be certified by the flight instructor conducting a flight review/endorsement or the flight examiner conducting a flight test. When certifying the documents, the following words should be used: 'This is a true copy of the original document, sighted by me [name], [signature], [date], [ARN]'

If CASA does not have a photo of the licence holder that is less than 10 years old, they must also submit [Lodgement of current photo with CASA](#) (Form 61-9PIC).

- The Low Level Rating is a new rating introduced under *CASR Part 61*. If applying for an endorsement on a Low Level Rating, such as Sling Operations, the rating is automatically granted.
- The CASR Part 61 Aerial Application Rating has replaced the CAR Part 5 Aerial Agricultural Rating and now includes Firefighting as an endorsement on that rating. You will need to submit form 61-2FF Transition of pilots authorised to conduct firefighting operations.
- There is no Low Level Rating under *CAR Part 5*. However, low level activities such as stock mustering, power-line inspection, fish spotting etc, could be conducted under the authority of an Instrument issued directly to an individual or indirectly under an operator's approval. If you can provide evidence of the conduct of these activities you may be eligible for issue of a Low Level Rating, with a category endorsement and/or additional endorsement(s), depending on the evidence provided.
