## Purpose of this form

Use this form to apply for a CASA issued RPL and associated endorsements through recognition of your pilot certificate granted by a Sports Aviation Body (SAB).

## Who is this form for?

This form is for individuals holding a pilot certificate granted by a SAB seeking recognition when applying for a CASA issued RPL.

## Information needed to complete this form

You must hold a current pilot certificate issued by a SAB.

You must provide certified copies of documents as a part of this application. For more information on certified copies and who can witness them, see the [CASA website](#).

If CASA does not have a photo of you that is less than 10 years old, you must also submit [Lodgement of current photo with CASA](#) (Form 61-9PIC) with this application.

A CASA Flight Crew Licence cannot be issued until you have been issued with an Aviation Security Identification Card (ASIC) or Aviation Identification (AVID). For security requirements associated with the issue of this licence please refer to the guidelines.

To be issued with a flight radio endorsement based on your pilot certificate, you will need to hold a valid International Civil Aviation Organisation (ICAO) level 4, or higher, Aviation English Proficiency (ELP) assessment or you are submitting an ELP notification with this application.

To be issued with a Recreational navigation endorsement your pilot certificate must authorise you to conduct cross-country flight and you must meet the minimum required hours.

## Aviation Reference Number (ARN)
