### **Certification Basis:**

The basis of certification is as prescribed in Type Certificate Data Sheet No A.022 issued by the European Aviation Safety Agency

#### Conditions and/or Limitations:

1. An aircraft issued with either an Export C of A issued by AustroControl (Austria) for an Austrian produced aircraft, or an Export C of A issued by Transport Canada for a Canadian produced aircraft, that identifies the aircraft complies with EASA TCDS A.022 is eligible for an Australian C of A.
