Airworthiness type certification basis:

Certificate of Airworthiness:

- (a) An example of the aircraft type and models shown on this data sheet is eligible for a standard certificate of airworthiness in the normal category.




- (b) An example of any of these models is also eligible for a certificate of airworthiness in the transport category if it complies with the requirements of section 101.4 of Civil Aviation Orders and other applicable requirements.

Aircraft Flight Manual:

Aircraft accepted under Type Certificate No VA501 shall be operated in accordance with Embraer Pilot's Operating Handbook, TP-110P1/176, latest revision. In addition, for those aircraft operating in transport category, a flight manual supplement is required to comply with CAO 101.4.

Revision 2 to this TCDS replaces Pilot Operating Handbook (POH) TP-110P2/151 with POH/AFM 110P1/176 and makes reference to the need for a flight manual supplement to comply with the requirements of CAO 101.4.

Revision 3 to this TCDS changes the Manufacturer/TC holder from Empresa Brasileira de Aeronautica S.A. (EMBRAER) to Yabora Industria Aeronautica S.A.
