Purpose of this form

Use this form to apply for approval of your proposed practices and procedures for tethered operations around controlled and non-controlled aerodromes.

Who is this form for?

This form is for RPA Operator's Certificate (ReOC) holders who want to conduct tethered operations around an aerodrome and who therefore need to seek approval from CASA of their practices and procedures.

Information needed to complete this form

ReOC holders should review the relevant CASR Part 101 and Manual of Standards provisions before completing this application.

Applicants are required to complete and submit all parts of the application to be acceptable to CASA.

The completion of this application form is the first step in the application process. On receipt of a completed application form, CASA will calculate and send you an estimate of the cost to process your application and any additional information you must submit.

Should you wish to proceed, you will need to pay the estimate.

CASA may refuse to consider an application or to consider it further while there are requirements that the applicant has not complied with.

Aviation Reference Number (ARN)

An ARN is an identifier that is similar to an account or customer number. You will need an ARN to complete this form.

If you do not have an ARN, apply for an ARN.

If you are applying on behalf of an organisation, you need to provide the organisation's ARN and have authority to act on behalf of the entity.
