## Purpose of this form

Use this form to submit, and apply for an approval of, the Training and Checking System section of an exposition or operations manual as part of the transition to Parts 119, 121, 133, 135, and 138 of the CASR, and specifically, compliance with sections 33, 34D, 38, 43 or 48 of CASA EX87/21 – Flight Operations Regulations – SMS, HFP&NTS and T&C Systems – Supplementary Exemptions and Directions Instrument 2021, and to nominate the HOTC of the organisation.

## Who is this form for?

This form is for all AOC holders who conduct air transport operations under Parts 121, 133, or 135 of the CASR, and Part 138 Aerial Work Certificate holders who require a Training and Checking System.

CASR 119.170 requires all Air Transport AOC holders to have a training and checking system.

CASR 138.125 requires Aerial Work Certificate holders who conduct any of the following operations to have a training and checking system:

- An operation transporting marine pilots
- An operation using offshore airborne radar approach procedures in accordance with section 8.6 of MOS Part 173 (Helicopter off-shore procedures airborne radar)
- An operation using the descent and operational procedures as follows:
  - > Rotorcraft IFR flight and VFR flight at night (MOS 138.9 D3)
  - Rotorcraft IFR flight that is a SAR operation involving an auto-hover using transition mode capability over the sea (Div 5 of Chap 9 of MOS Part 138)
  - Aircraft IFR flight below minimum height over the sea (Div 4 of Chap 9 of MOS Part 138)
- An operation that is an NVIS operation
- An operation using a multi-engine rotorcraft with MTOW above 3,175kg that is type certificated in the restricted category
- An operation using a multi-engine rotorcraft with MTOW above 3,175kg that is type certificated in the transport category
- An operation in turbine-engine aeroplanes (other than turbineengine propeller-driven aeroplanes)
- An operation in multi-engine aeroplanes with a MTOW of more than 5,700kg
- An operation for the purposes of training or checking air crew members under the MOS 138.24
