Purpose of this form

Use this form to notify CASA of any errors or omissions regarding your CASR Part 61 Flight Crew Licence.

Who is this form for?

This form is for holders of a current CASR Part 61 Flight Crew Licence in the following circumstances:

- you have been given additional privileges that you believe you are not entitled to
- you applied for permissions which do not appear on your Licence and you have already submitted a Recognition and Transfer CAR Part 5 Qualifications (Form 61-9TX)

Information needed to complete this form

These permissions could either be contained in your logbook or on an instrument or as a result of an authorisation under an AOC. It also includes a section for recording your last flight review or renewal (called a proficiency check under Part 61) of a rating.

You will need supporting documentation for any new or absent permissions.

If you believe your Part 61 Flight Crew Licence contains errors please attach a copy of your Licence with these errors highlighted.

Aviation Reference Number (ARN)

An ARN is required to complete this form.

If you are the applicant and you do not have an ARN, [apply now](#).

2 Checking your new CASR Part 61 Licence

- **Step 1:** Check your ARN, name and date of birth are correct
- **Step 2:** Check your licence/ratings/endorsements

Licences are no longer issued as category specific, so if you held a CP(A)L under CAR Part 5 you will be issued a CPL-A under Part 61. If you also held a CP(H)L you will see both the Aeroplane and Helicopter categories listed under your Commercial Pilot Licence.

You will not see a Student Pilot Licence, Restricted Flight Engineer Licence or Student Flight Engineer Licence as these qualifications have not transitioned to Part 61 qualifications.

- **Step 3:** Check your Aircraft Ratings and aircraft Design Feature Endorsements (DFE)

All multi-engine aeroplane endorsements listed on your CAR Part 5 licence that are not type ratings will not appear on your Part 61 licence, these are covered by the Multi-Engine Aeroplane (MEA) Class Rating.

Refer Part 61 Legislative Instrument for Type Ratings.

Confirm you have the appropriate Aircraft Category – Class or Type Ratings issued on your licence. Refer to page 17 on your Licence under 'Conditions/Licence Remarks' for confirmation.

There have been some minor changes to the list of DFE under Part 61. You will need to check those listed on your Licence against the list of endorsements in the regulation 61.755.

New Design Features are to be submitted via form [Issue of CASR Part 61 Design Feature \(form 61-3DF\)](#).

Historical Design Features can be converted from your CAR Part 5 Licence to your Part 61 Flight Crew Licence by submitting [Recognition and Transfer CAR Part 5 Qualifications \(Form 61-9TX\)](#).

- **Step 4:** Check **all** your Operational Ratings and Endorsements

This section will require very careful review.

Part 61 has introduced the concept of Endorsements on Operational Ratings, an Operational Rating **cannot** exist without at least one endorsement issued on it.

Some Endorsements for which you are eligible to hold on Operational Ratings listed on your Part 61 Licence may not be listed as they will require you to apply for them to be listed via [Recognition and Transfer CAR Part 5 Qualifications \(Form 61-9TX\)](#).

If you hold an Instructor Rating, ensure the Endorsements that reflect the privileges of the Grade of rating you held under CAR Part 5 are listed eg Grade 1 Aeroplane – you have Instrument Rating and Instructor Rating Training Endorsements listed.

For the Instrument Rating only IAP2D, IAP3D, IR-SEA, IR-MEA, IR-MEH will be listed and **not** specific NAV AIDS.

- **Step 5:** Check **all** your Flight Activity Endorsements

Check the CASR Part 61 regulation 61.1145 for what are flight activity endorsements under the regulation.

If the flight activity is not listed under Part 61 then it will not appear on your Licence.

If you hold a flight activity listed under Part 61 that is not listed, **have you** completed and submitted [Recognition and Transfer CAR Part 5 Qualifications \(Form 61-9TX\)](#).

- **Step 6:** Check the Table – “Flight Review and Proficiency Check – Aircraft Ratings and Operational Ratings”

This table is for the recording of a successful revalidation of a qualification that requires either a flight review or proficiency check under CASR Part 61.

As logbooks are no longer used for the recording of revalidation, it is important you check this table to confirm your last flight review/proficiency check is printed here.

Notifications received by CASA appear here.

Flight reviews will not be issued based solely on a proficiency check.

IPC on a class rating is covered under CASR 61.745(3)

IPC on a type rating is covered under CASR 61.800(4)
