# CASA OAR 301/23 – Temporary Restricted Area – Declaration and Determination (Byron Group TIBA) Instrument 2023

## 1 Name

This instrument is CASA OAR 301/23 – Temporary Restricted Area – Declaration and Determination (Byron Group TIBA) Instrument 2023.

#### 2 Duration

This instrument:

- (a) commences on 14 December 2023; and
- (b) is repealed at the end of 14 December 2023.

*Note*: Dates in this provision are in Coordinated Universal Time (UTC).

#### 3 Declaration

- (1) I declare the area specified in Schedule 1 to be a temporary restricted area.
- (2) Any conditions in accordance with which the flight of aircraft within the area is permitted are set out in Schedule 1.

### 4 Activation of declaration

The declaration of the area specified in Schedule 1 is activated by the event mentioned in the activation clause for the area.

#### 5 Determination that ATS are at variance with Annex 11

(1) I determine that, in accordance with Annex 11 to the Chicago Convention, the air traffic services (*ATS*) to be provided for the airspace within the declared area

are services that are at variance with the ATS that would otherwise be provided, in accordance with the Annex, for the airspace within the declared area.

(2) The services that are at variance are set out in Schedule 1.

This instrument operates subject to the effect of CASA 57/23 – Australian-administered Airspace outside Australian Territory – Temporary TIBA Areas – Directions Instrument 2023.
