



Guidelines

Certain air operators may use this form to apply for an Chicago Convention (ICAO) Annex compliant Operations Specification (Ops Spec). The ICAO compliant Ops Spec is primarily for those operators that conduct international commercial air transport operations.

CAO 82.5 Section 9A, (reflected in AIP GEN1.5-18) details the requirements for Australian operators conducting international commercial air transport operations to present and carry copies of the AOC and Ops Spec on the aircraft.

In accordance with ICAO Annex 6, the Ops Spec is required to follow the format as described in ICAO Annex 6 Part 1 Appendix 6 Section 3.

In order to comply with this ICAO requirement, an additional Schedule with an ICAO compliant Ops Spec embedded, will be added at the end of the current issued Australian AOC holder's Ops Spec.

Other CASA issued authorisations detailed in the ICAO compliant Ops Spec are not be required to be carried on the aircraft. The ICAO compliant Ops Spec details the conditions, limitations and specific authorisations held by the operator which can be easily referenced and checked by an inspector. This application form requires details of these specific CASA authorisations to be provided, i.e. authorisation number and expiry date. These details will be included in the "Remarks" section of the ICAO compliant Ops Spec.

The ICAO compliant Ops Spec will be issued for each aircraft identified by aircraft make, model and series. This Ops Spec will only reference the specific authorisations and potentially conditions and limitations, applicable to the specific aircraft model and series, as required by the Annex. It is possible that two aircraft of the same model and series may need two different Ops Specs depending on the specific approvals applicable to the specific aircraft, i.e. two aircraft with different LVO or EDTO specific approvals.

The ICAO Ops Spec will not replace the current issued Australian AOC Ops Spec but will be an addendum to it.

Completion of all details in Part B will provide the information to populate the required fields of the ICAO compliant Ops Spec.
