## Who is this form for?

This form is for RPA Operator's Certificate (ReOC) holders who wish to apply for specific flight authorisations listed above. This form should be submitted by the Chief Remote Pilot.

## Information needed to complete this form

ReOC holders should review the relevant CASR Part 101 Regulations and Manual of Standards before completing this application. Applicants are required to complete and submit ALL parts of the application to be acceptable to CASA.

The completion of this application form is the first step in the application process. On receipt of a completed application form, CASA will calculate and send you an estimate of the cost to process your application and any additional information you must submit.

Should you wish to proceed, you will need to pay the estimate and send any requested documents to the RPAS Team.

CASA may refuse to consider an application or to consider it further while there are requirements that the applicant has not complied with.

If this is your first BVLOS application, please contact RPAS Branch to arrange a pre-application meeting.
