



IMPORTANT INFORMATION

- 1: If the applicant does not *currently* have a CASR Part 61 licence document, you **must** submit [Form 61-9TX](#) with this application. Refer to the 9TX form for further information. If CASA does not have a photo of the applicant that is less than 10 years old, you must also submit [Form 61-9PIC](#).
- 2: This form is to be used by pilots to apply for the grant of an aircraft firefighting authorisation. Pilots must satisfy the relevant requirements, provide appropriate evidence with this application and have the head of flying operations, complete the declaration in Section B of the form. Section B does not have to be completed by the head of flying operations for whom the applicant is currently working.
- 3: To be granted an aeroplane firefighting endorsement, you must meet the following requirements:
 - Hold, or be taken to hold, a CASR Part 61 aerial application rating, which is equivalent to a CAR Part 5 agricultural pilot (aeroplane) rating
 - Prior to 1 September 2014, have undertaken firefighting operations training provided by the operator in accordance with its operations manual
 - Prior to 1 September 2014, have conducted firefighting operations in an aeroplane
- 4: To be granted a helicopter firefighting endorsement, you must meet the following requirements:
 - Prior to 1 September 2014, have held the minimum qualifications for water dropping by a helicopter engaged in firefighting operations in accordance with CAO 29.5 (as in force prior to 1 September 2014)
 - Prior to 1 September 2014, have conducted firefighting operations in a helicopter
 - Prior to 1 September 2014, have undertaken firefighting operations training provided by the operator in accordance with its operations manual
- 5: This form can be **completed electronically and saved locally** to your computer. Once the applicant's ARN has been entered into the first page, it will automatically update in the ARN fields on subsequent pages. **Fields and sections marked with an * are mandatory.** CASA recommends that you complete as much of the form electronically as possible.
