



IMPORTANT INFORMATION

- 1: If the licence holder does not *currently* have a CASR Part 61 licence document, they **must** submit Form 61-9TX. Refer to the form for further information. If CASA does not have a photo of the licence holder that is less than 10 years old, they must also submit Form 61-9PIC.
- 2: The issue of the first CASR Part 61 licence is free of charge. If the licence holder wishes for a subsequent reprint of their licence, they must complete and submit Form 61-9R.
- 3: This form is to be used to notify CASA of the completion of a proficiency check for any operational rating under CASR Part 61.
- 4: This form can be **completed electronically and saved locally** to your computer. Once the licence holder's ARN has been entered into the first page, it will automatically update in the ARN fields on subsequent pages. CASA recommends that you complete as much of the form electronically as possible. **Fields and sections marked with an * are mandatory.**
